 - A student has to present a dissertation-related topic seminar and progress report in English with appropriate presentation skills once per semester for at least three semesters and attend a seminar every semester during the study. The seminar will be arranged according

to the protocol set by the Graduate Study Administrative Committee.

2) At least two dissertation works or parts of dissertation work must be published or accepted to publish having the student as the first author in an international journal. One must be listed in ISI, Scopus, IEEE, PubMed or Web of Science database. At least one dissertation work or a part of dissertation work must be presented in an international conference accepted by the field of study.

For a student who attends the double degree program, each student must have at least two publications having the student as the first author in an international journal listed in ISI, Scopus, IEEE, PubMed or Web of Science database. At least one publication must have a corresponding author from Faculty of Pharmacy, Chiang Mai University, and at least one publication must have a corresponding author from Graduate School of Pharmaceutical Sciences, Chiba University. At least one dissertation work or a part of dissertation work must be presented in an international conference accepted by the field of study.

- 3) A student has to report his/her dissertation progression using the Graduate School dissertation progress report form. The dissertation progress reports have to be approved by the Chairperson of the Graduate Study Committee of the Faculty of Pharmacy and submitted to the Graduate School every semester.
- 4) A student who has to do animal testing or clinical study or biotechnology must be certified about the ethical and legal issues in research involving animal or human experimentations or biotechnological study before starting a dissertation. A student conducting research using plant variety must obtain permission from the Plant Variety Protection Division, with a letter of approval from the Plant Variety Protection Office, according to the Plant Variety Protection Act, B.E. 2542, Section 53.
- 5) Thai student who participates the double degree program is required to have his/her dissertation proposal approved by the Graduate Study Committee of the Faculty of Pharmacy, Chiang Mai University before doing dissertation work at Graduate School of Pharmaceutical Sciences, Chiba University. Furthermore, Thai students are expected to complete all courses and any academic works required to satisfy the requirements at the Graduate School of Pharmaceutical Sciences, Chiba University. On the other hand, the students from Chiba University are also required to implement all academic activities provided and supervised by the Graduate Study Committee of the Faculty of Pharmacy, Chiang Mai University.

- 2) At least two dissertation works or a part of dissertation work must be published or accepted to publish in an international journal listed in ISI, Scopus, IEEE, PubMed or Web of Science database. The publications must have the student as the first author. At least one dissertation work or a part of dissertation work must be presented in an international conference accepted by the field of study.

For a student who attends the double degree program, each student must have at least three publications having the student as the first author in an international journal listed in ISI, Scopus, IEEE, PubMed or Web of Science database. At least two publications must have corresponding authors from Faculty of Pharmacy, Chiang Mai University. At least one publication must have a corresponding author from Graduate School of Pharmaceutical Sciences, Chiba University. At least one dissertation work or a part of dissertation work must be presented in an international conference accepted by the field of study.

- 3) A student has to report his/her dissertation progression using the Graduate School dissertation progress report form. The dissertation progress reports have to be approved by the Chairperson of the Graduate Study Committee of the Faculty of Pharmacy and submitted to the Graduate School every semester.
- 4) A student who has to do animal testing or clinical study or biotechnology must be certified about the ethical and legal issues in research involving animal or human experimentations or biotechnological study before starting a dissertation. A student conducting research using plant variety must obtain permission from the Plant Variety Protection Division, with a letter of approval from the Plant Variety Protection Office, according to the Plant Variety Protection Act, B.E. 2542, Section 53.
